Daily Clean 450 is a neutral pH cleaner especially designed for cleaning little to moderately soiled floors. Daily use of Daily Clean 450 with a regular maintained program can extend the life of the floor.

DAILY CLEAN 450 DAILY CLEANER is an effective general purpose cleaner for removing light to moderate soiled Floors in facilities such as schools, institutional facilities, office buildings, restaurants, etc. DAILY CLEAN 450 DAILY CLEANER is easy to use and provides economical care for both small and large facilities.

Directions: For daily cleaning light soiled floors use a solution of 4 to 8 oz. per gallon of water. For medium to heavy soiled areas use a solution of 8 to 16 oz. per gallon of water. Apply with a damp mop using only the amount of required cleaning solution. Using more cleaner than you need, could leave a residue on the floor. Let solution work for a few moments while you dampen the next area. The extra time gives the cleaning solution time to dissolve the soil. Then, dip the mop again and wring it out thoroughly. Go back over the area to pick up the water and dirt. Daily Clean 450 may be diluted in similar fashion and used in a trigger sprayer with a damp cloth or sponge for cleaning small surfaces. Chem-Coat Industries, also offers Stampede which is a Cleaner and Degreaser. Stampede is intended for use in industrial, commercial and institutional cleaning on tough grease and oil stains. Before cleaning, place warning signs in regards to wet floor around work area. Always place warning signs when cleaning the floors. Do not remove the signs until the floor is completely dry and safe to walk on.

Do a small test area before project starts to assure compatibility of all products, an approval.
